

## **Description**

## Payments:

Payments must be received to Property Peddler Inc. by 5PM on Wednesday, April 2nd.

Payments can be made in cash, personal check (Made to Property Peddler) if you are a local resident, by debit/credit card with a 3.5% service fee, or by electronic transfer. Credit and debit card sales will be handled **over the phone (618-473-2500), not** through the auction software. This allows us to schedule your pick up and get the information from you that we need to have for your 72 hr waiting period.

**Buyer pays for all gun transfers**. Buyers are responsible for the Transferring Fee of \$35.00 each (for first 2 transactions, \$15 each after that, within the same day's sale) paid to Mud Creek Guns and Ammo. Out-of-State Buyers: Laws vary if you live outside of Illinois. Before bidding contact Marcy Specogni of Mud Creek Guns and Ammo at 618-559-7849 to determine what regulations will be followed and how much transferring fees will be if you win the firearm.

**Waiting Period:** There is a 72 hr. waiting period that begins when you turn in your State ID / FOID card (IL Residents) to be cleared for pick up.

**Long Distance Buyers pay for shipping** and it will be sent to the FFL of your choice. It will be up to the buyer to secure the destination with Marcy Specogni of Mud Creek Guns and Ammo. Mud Creek Guns and Ammo can only handle transfers to residents of Illinois or its bordering states (Indiana, Kentucky, and Missouri) if you want to pick up your gun at our

location. Residents of any other state will have to have their purchases shipped to their local FFL.

## Marcy Specogni of Mud Creek Guns and Ammo will be in office to start transfer paperwork

- Saturday, March 29th (Auction Closing) from 10AM to 2PM
- The following week Monday, March 31st through Friday, April 4th from 9AM to 5PM.
- Your 72 hr. waiting period begins when you pay and present your ID and FOID card (if applicable) to Property Peddler or Marcy Specogni.

So for example if you are in on Saturday to pay & present ID, your gun can be picked up at our location on Tuesday. If you call in and pay with a credit or debit card, and send a picture of the front of your DL and FOID card, we can forward to Marcy Specogni and your waiting period begins then also. As long as your payment and info is received by the end of the day on Tuesday, you can pick up your firearm here at our Sparta, IL location on Thursday or Friday.

If you wait until Wednesday to get your invoice paid and present ID, your 72hr period of waiting time will exceed the pick up week for our Sparta Location. You will then pick up your firearm at Mud Creek Guns and Ammo location in Coulterville. You will need to contact Marcy Specogni to arrange a pick up.

Any Firearms not picked up by Friday at our Sparta, IL location will return with the FFL at Mud Creek's location listed at the top of this page. Later pick ups will be arranged with Mud Creek. As long as your payment and info is received by the end of the day on Tuesday, you can pick up your firearm here at our Sparta, IL location.

\*\*\*\* Some firearms are noted that they cannot be sold to an Illinois resident unless the buver is a qualified law enforcement officers, military, or retired law enforcement or military. Please read the qualifications specified below. 720 ILCS 5/24-1.9(e)(2)(assault weapon ban) and 720 ILCS 5/241.10(e)(2)(large capacity ammunition ban) considers "qualified law enforcement officers" to mean any employee of a governmental agency who— is authorized by law to engage in or supervise the prevention, detection, investigation, or prosecution of, or the incarceration of any person for, any violation of law, and has statutory powers of arrest or apprehension; is authorized by the agency to carry a firearm; is not the subject of any disciplinary action by the agency which could result in suspension or loss of police powers; meets standards, if any, established by the agency which require the employee to regularly qualify in the use of a firearm; is not under the influence of alcohol or another intoxicating or hallucinatory drug or substance; and is not prohibited by Federal law from receiving a firearm. 18 U.S.C. 926(C) defines "qualified retired law enforcement officers" to mean an individual who— separated from service in good standing from service with a public agency as a law enforcement officer; before such separation, was authorized by law to engage in or supervise the prevention, detection, investigation, or prosecution of, or the incarceration of any person for, any violation of law, and had statutory powers of arrest or apprehension under section 807(b) of title 10, United States Code (article 7(b) of the Uniform Code of Military Justice); (A) before such separation, served as a law enforcement officer for an aggregate of 10 years or more; or (B) separated from

service with such agency, after completing any applicable probationary period of such service, due to a service-connected disability, as determined by such agency; during the most recent 12-month period, has met, at the expense of the individual, the standards for qualification in firearms training for active law enforcement officers, as determined by the former agency of the individual, the State in which the individual resides or, if the State has not established such standards, either a law enforcement agency within the State in which the individual resides or the standards used by a certified firearms instructor that is qualified to conduct a firearms qualification test for active duty officers within that State; (A) has not been officially found by a qualified medical professional employed by the agency to be unqualified for reasons relating to mental health and as a result of this finding will not be issued the photographic identification as described in subsection (d)(1); or (B) has not entered into an agreement with the agency from which the individual is separating from service in which that individual acknowledges he or she is not qualified under this section for reasons relating to mental health and for those reasons will not receive or accept the photographic identification as described in subsection (d)(1); is not under the influence of alcohol or another intoxicating or hallucinatory drug or substance; and is not prohibited by Federal law from receiving a firearm. Mud Creek Guns and Ammo requires proof that the buyer meets these conditions prior to transferring a regulated weapon or large capacity ammunition device.
